FRONSAC ANNOUNCES AN ACQUISITION

Montreal (Québec) - (TSX-V: GAZ.UN) Fronsac Real Estate Investment Trust (“**Fronsac REIT**” or “**Fronsac**”) is pleased to announce the acquisition of a property located in Gatineau, Qc. The property is a retail store operated by Staples Canada under the Bureau en Gros banner and was acquired under a sale and lease-back agreement with Staples Canada. Total consideration paid for the property was \$7,500,000 (excluding transaction costs) and was settled in cash, representing a 6.5% capitalization rate on the average net operating income of the property for the next five years. There are no previous ties between Fronsac and Staples Canada prior to the transaction.
